VITFF Bulletin: Youth Track and Field Qualifiers for CAC Age Group Championships...



The Virgin Islands Track and Field Federation announced today that the V.I. National Youth Track and Field Team has been selected and will compete in The XIV CAC Age Group Track and Field Championships to be held in Tortola, BVI July 1-2, 2011.

The CAC Age Group Championships are for the top 8 boys and girls 11-12 and 13-14 years of age from each Central America and Caribbean country. The V.I. athletes qualified by competing in CAC Age Group trials competition held in BVI and St. Croix the past weekend. The 11-12 year olds will compete in the Pentathlon (combined 5 events including: 60m, Baseball Throw, Long Jump, High Jump, 800m/1000m); the 13-14 year olds will compete in the Heptathlon (combined 7 events including: 60m hurdles/80m hurdles, 80m, Baseball Throw,



Long Jump, High Jump, Shot Put, 1000m/1200m). The athletes are scored according to the number of points they accumulate after completing these events.

The CAC Age Group Championships provides National Youth Team athletes the first opportunity to compete in an official regional championships. The V.I. National Age Group Team is supported by a grant from the V.I. Department of Housing, Parks and Recreation and the VITFF. The V.I. Age Group Trials were organized by The St.Croix Track Club and The V.I.Pace Runners.
